## Rental Terms and Conditions

- Prices are in EURO, are not subject to discounts and include Unlimited Km (U.N.L.), Third Party Insurance (T.P.I.), Collision Damage Waiver (C.D.W.) and VAT.
- VAT (23%) is included (16% VAT for the following areas: Rhodes, Lesvos, Mykonos, Skiathos, Naxos, Paros, Kos, Santorini, Samos, Karpathos, Chios, Thasos, Tinos).
- Minimum rental: 1 day, with the 25th hour offered for free. After 25 hours, drivers will be charged an additional day.
- Vehicles will be handed over with a full tank of petrol, and must be returned with a full tank (only unleaded). If not, the driver will be charged an additional 1,75€/litre for the petrol used, as well as 10,00 € + VAT for a refill (amount may vary depending on average petrol prices).
- Any fines or charges caused by breaches of the Highway Code will be the customer's responsibility.
- All "Sixt" vehicles are insured:
  - for all third parties (excluding the driver) for death and physical damage up to 750.000,00 € per person
  - for material damage of third parties up to 750.000.00 € (excluding Sixt vehicle)
  - for damage inflicted on Sixt vehicle in case of fire. For damages or theft due to the driver's negligence or carelessness, the driver is responsible for all damages that equal the market value of the vehicle at the time of the accident or theft.
- With the Collision Waiver Insurance, drivers limit their responsibility for all damages as mentioned in the aforementioned "Waiver Cost", provided the damages are not a result of breaching the Highway Code.
- No insurance covers the cost of damages caused by Highway Code infringements, as well as any damages inflicted on tires, mirrors, window cleaners and on the vehicle's exterior (underneath) and interior.
- Accident file expenses: Drivers are charged 15,00 € + VAT in case of an accident. This amount is non-refundable.
- Fines and charges: Drivers are responsible for payment of any fines or charges caused by breaches of the Highway Code during the entire car rental.
- In case these are not paid by the driver and Sixt has to intervene for their payment, a further 20,00 € + VAT will be charged in addition to the fines.
- Loss or destruction of key: In case of loss or destruction of car key during rental period, drivers will be liable for:
  - 60.00€ + VAT for the categories MCMR. EDMR. CCMR
  - 100.00€ + VAT for the categories CDMR. IDMR, SDMR, CDAR, SDAR, CWMR. SVMR, CFMN. ITMR
  - 200.00€ + VAT for the categories FVMR. PDMR. XDMR. FFMR
- Car seats and snow chains are available only upon reservation and with an additional charge of 3,00 € + VAT per day.
- Additional Driver (A.DR.): Additional charge of 3,50 € + VAT per day.
- GPS system is available only upon reservation and if available with an additional charge of 5.00 € + VAT per day.
- Airport Tax is not included (13% for Athens International Airport and 6% for all other airports). Airport tax is valid only when car pick-up occurs at the airport.
- Vehicle interior: In case the vehicle is returned with stains that require special cleaning (eg: hair/sand on seats, floor or trunk etc), drivers will be charged 80.00 € + VAT.
- Pick up/Drop off: Within city limits 14.00€ + VAT – Outside city limits and until 80km from closest Sixt station: 25.00€ + VAT – Pick up/Drop off outside of working hours (please consult relevant station list): 20.00€ + VAT (except Athens International Airport).
- "Hire here – drop off there" system available: Free of charge for at least five (5) days rental between the cities of Athens, Kinetta, Thessaloniki, Halkidiki, Kavala, Alexandroupoli, Ioannina, Volos, Patra, and in Crete between the cities of Irakleio, Hania, Rethimno and Agios Nikolaos following written permission from Sixt Hellas. For other areas and one to four (1-4) day rentals, please consult the Reservations Department or any Sixt store in Greece regarding extra charges.
- For MCMR, EDMR and CCMR vehicles the minimum age for drivers is 23 and 25 for all other categories. A personal credit card is also required as guarantee.
- Drivers between the age of 21-22 are subject to a New Driver's daily charge of 20,00 € + VAT.
- Transporting car on ferries: Not permitted.
- Travelling abroad: Not permitted
- The rates and terms of rental may be changed without notice.
